Dear Governor Northam:

As we continue to deal with the historic COVID-19 emergency, I am writing to request your consideration for a measured opening of our beaches during Phase One of the Virginia Forward Blueprint. As you know our 28 miles of beaches on the Atlantic Ocean and Chesapeake Bay help create one of the top economic engines for our City and the Commonwealth. More importantly, research shows that beaches offer mental health benefits through rest, relaxation, meditation and exercise. We have an opportunity to provide that safe outlet for residents and visitors on one of the widest beaches on the East Coast.

As you consider guidelines for Phase One openings, Virginia Beach is prepared to recommend the following parameters by which the beaches open:

1. Posting of public safety placards regarding social distancing, cleaning & PPE protocols
2. Deploy a safety ambassador patrol to encourage adherence to protocols and augment enforcement efforts on the beach, boardwalk and in parking facilities
3. Promote physical distancing and no more than 10 people in group gatherings
4. Increased cleaning of benches, bathrooms, showers and railings at access points and deploy sanitation stations
5. No programming of mass gatherings or entertainment and continued closure of beach playgrounds
6. Reduction in parking capacity at garages and dispersal of on-street parking
7. Suspension of the bus trolley service

We are prepared to assist with adherence to business safety restrictions, continued social distancing, continued teleworking and promotion of face coverings in public.
